2. One, brandon-albert: Sibley and one [REDACTED] Sibley are to be addressed here after without the use of any appellations, abbreviations, titles, or nom de guerres, which could be presumed to lower the status of the living man and woman to that of a subject or voluntary slave.
3. On January 11, 2021, one [REDACTED] Sibley and her property, were denied access to the Denham Springs Library, located at 8101 U.S. Hwy 190, Denham Springs, Louisiana 70726 for failing to comply with the Mask Mandate. One, [REDACTED] Sibley informed Trevor, building manager, that she and her property were in fact exempt from the Governors mandate. The exemption was denied by Trevor and the staff working.

4. On the date of 1/11/2021, one, brandon-albert: Sibley, called the building manager Trevor and received Giovanni Tairov's email and phone number. It was at this time that an email was sent notifying Giovanni Tairov of the deprivation of rights under color of law.
5. "I need a copy of the Denham Springs Public Library public policy that states where the Denham Springs public library is gaining its authority to deny access to its facilities. I also need a copy of what law the Denham Springs library is operating under which allows their librarians to have the ability to arbitrate, judge and ultimately deny access to its facilities on the grounds of one man or woman not looking like another group of men or women. I will also need to know by what authority the Denham Springs Library extends its public policy for its employees to the people it serves."
6. COLOR- An appearance, semblance, or simulacrum, as distinguished from that which is real. A prima facie or apparent right. Hence, a deceptive appearance; a plausible, assumed exterior, concealing a lack of reality; a disguise or pretext.
7. On January 14, 2021, attorney Christopher Moody emailed a response letter stating the authority granting the Denham Springs Library the power to deny service at a place of public accommodation to a private man and woman was in fact John Bel Edwards proclamation 89.
8. John Bel Edwards mandated on July 24<sup>th</sup> 2020 in proclamation 89 section 4 (a), "Every individual in Louisiana shall wear a face covering over the nose and mouth when inside a commercial establishment or any other building or space open to the public, whether indoor or outdoor. This shall include public or commercial mode of transportation."
9. Section 5 of Proclamation 89 lists the statutes and the source of authority for the proclamation as La. R.S. 29:721, et seq., and La. R.S. 29:760. Title 29 of Louisiana statutes is the source authority for all emergency doctrines.
