As of November 2019, Gates had an estimated net worth of \$107 billion. That's more than the budgets of several third world countries. He got himself a PR firm and used them to help his image morph into a "world class philanthropist" and, with his wife Melinda, create the largest foundation on the planet – cleverly named the Bill and Melinda Gates Foundation.

The transition from tech CEO to global philanthropist was profound and brought Gates' global purposes to the fore. Target #1, vaccinate every human on the planet.

The stark contrast between his warm-hearted statements toward his fellow man and the planet's children and how his vaccination programs have ravaged those populations, particularly children of third world countries, is a classic example of the need to *Look. Don't Listen.*

The World Health Organization is generally considered to be the senior health organization on the planet, at least in name.

It is a special agency of the United Nations. Its mandate is care and protection of international public health. It was established on April 7th, 1948, and is headquartered in Geneva, Switzerland.

However, when one peels the onion of the group's thinly layered PR, the WHO's reputation among those that work in the field and know is one of negligence, abuse and corruption.

There is no better example of this than the current Director-General of the WHO, Tedros Adhanom Ghebreyesus.

The Global Fund is a public-private partnership with governments, world health bodies and over a dozen pharmaceutical companies. It was formed to fight AIDS tuberculosis and malaria.

NEW VACCINES FOR A SAFER WORLD

The Coalition for Epidemic Preparedness Innovations (CEPI) was launched at the world economic forum in Davos to develop

2. In 2017 the Indian government asked Gates to leave the country. This resulted from Gates earlier taking control of one of India’s national immunization programs, which mandated up to 50 doses of polio vaccines to children before the age of five.

The Gates program paralyzed 490,000 children between 2000 and 2017, at which point the Indian government threw him out of the country. Date coincident with the ousting, the paralysis epidemic “dropped precipitously”.

Approximately 1,200 suffered severe side effects, including autoimmune and fertility disorders. Seven died. Indian government investigators charged that Gate-funded researchers committed pervasive ethical violations pressuring vulnerable village girls into the trial, bullying parents, forging consent forms, and refusing medical care to the injured girls."*

*"The Case is now in the country's Supreme Court."*

*"In 2010, the Gates foundation funded a phase 3 trial of Glaxo Smith Kline's experimental malaria vaccine killing 151 African infants and causing serious adverse effects including paralysis, seizure, and febrile convulsions to 1048 of the 5949 children."*

6. In 2002, Gates' operatives in his MenAfriVac campaign in sub-Saharan Africa

forcibly vaccinated thousands of African children against meningitis. Approximately 50 of the 500 children vaccinated developed paralysis. South African newspapers complained 'We are guinea pigs for drug makers.' Nelson Mandela's former Senior economist, Prof. Patrick Bond, described Gates' philanthropic practices as "ruthless and immoral."
